The form indicated that the Jetstar arrived at LaGuardia on July 20, 1976, at 8:39 P.M. and departed on July 23, 1976, at 12:1 P.M. Landing fee, parking fee, and 580 gallons of fuel costing a total of \$601.77 were paid for in cash but there was no record as to who made the payment. These records can be obtained upon issuance of a subpoens.

Investigation at Miami has determined that there is no telephone credit card outstanding for FRED PRO in the Miami area.

On April 20, 1978, PHILLIP KARL KITZER, JR., appeared in U. S. District Court, Memphis, Tennessee, before U. S. District Judge HARRY WELLFORD and entered a plea of guilty to Counts 1, 16, and 17 of the indictment returned against him and the co-conspirators.

AITZER was then sentenced to five years on Count 1 and five years on Count 16 to run concurrently with each other and also concurrently with an existing federal sentence which KITZER is presently serving.
